WHAT IS eLAPS?

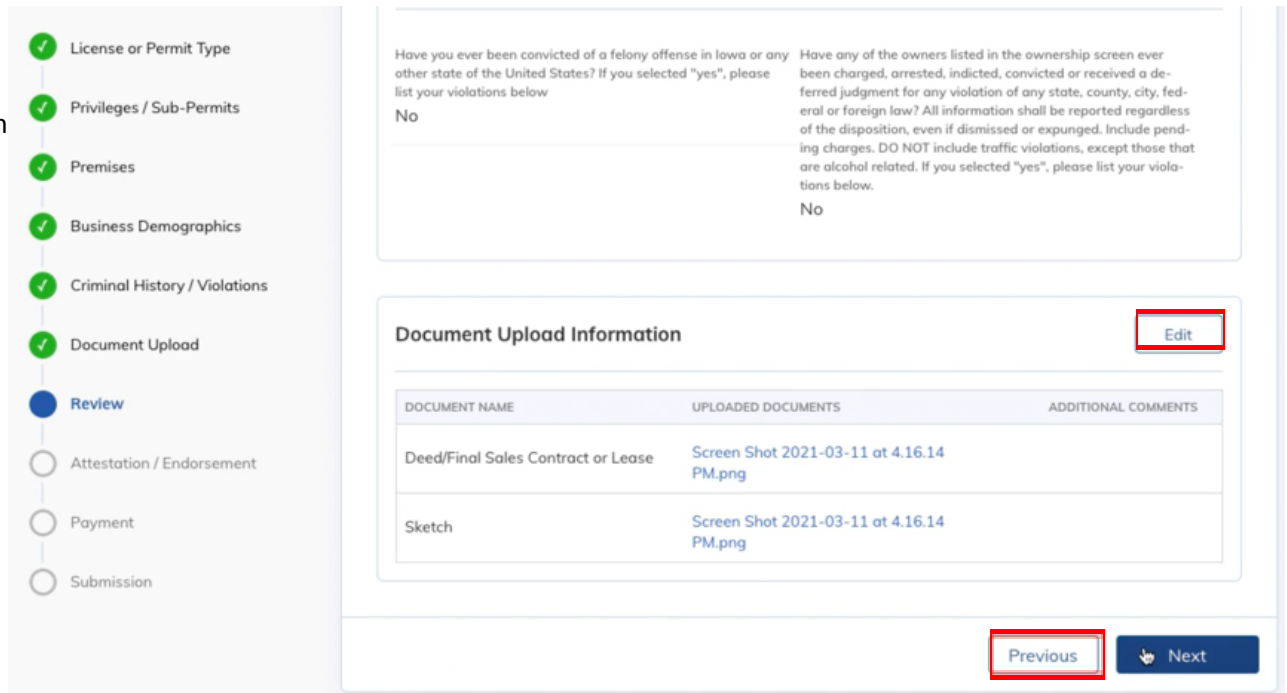
The Iowa ABD has partnered with MTX Group to develop the Electronic Licensing and Permitting System (eLAPS) in the Salesforce environment. eLAPS is designed to help local authorities and applicants in Iowa apply for, manage, and track alcohol licenses, permits, and certificates online.



Hot Tip #1

The Review step is where you can review the application information.

Click "Edit" or "Previous" to go back and make changes.

 **Hot Tip #2**

In the Criminal History, you do not need to include traffic violations, unless they are alcohol related.

All other criminal charges, regardless of the disposition, need to be reported - even if they were dismissed or expunged.

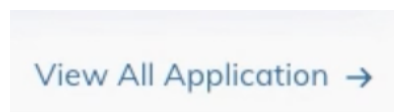
